1. STUDENT | PRE-PROFESSIONAL

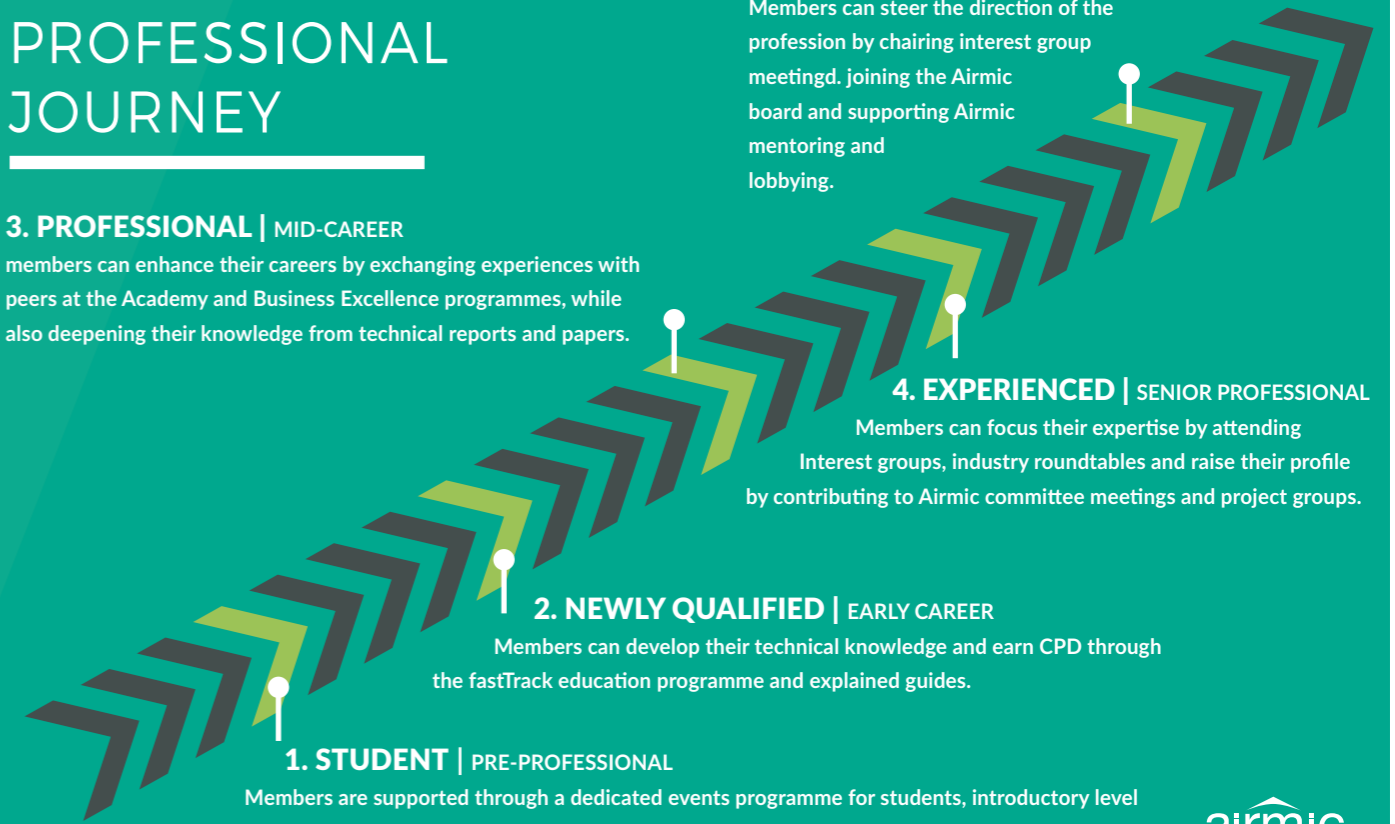
Members are supported through a dedicated events programme for students, introductory level workshops and opportunities to network with peers and learn from more experienced members.
