



# fastTrack

fastTrack is a rolling two-year Programme of interactive workshops supported by an annual Forum. Currently in Year Two, the Programme is designed for risk and insurance professionals in the first four years of their Professional Journey. Each year consists of a risk stream and an insurance stream. Although designed for professionals in the early years of their Professional Journey, any Airmic member may attend all or some of the workshops in either stream. Each workshop (delivered face to face or online via a webinar) has the objective of providing you with a fundamental understanding of the principles of risk management and insurance.

The annual *fast*Track Forum is one of the few Airmic events also open to employees of Airmic sponsors. This is to encourage professional development and networking in a collaborative environment.
