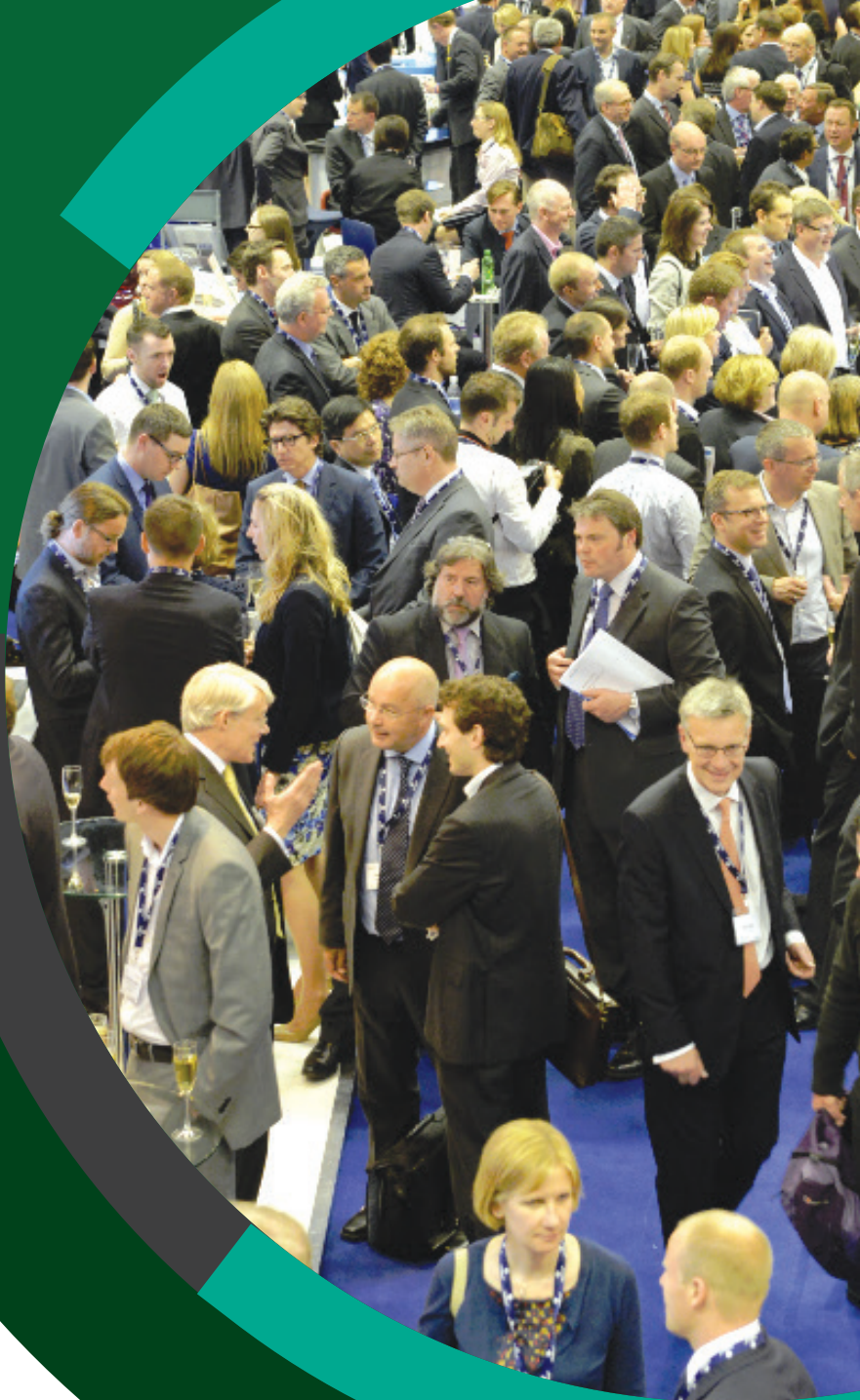

About Airmic Membership

Airmic has a membership of about **1200** from about **480** companies. It represents the Insurance buyers for about **70%** of the FTSE 100, as well as a very substantial representation in the mid-250 and other smaller companies. Membership continues to grow, and retention remains at **90%**.

Airmic members' controls about £5 billion of annual insurance premium spend. A further £2 billion of premium spend is allocated to captive insurance companies within member organisations.

Additionally, members are responsible for the payment of insurance claims from their business finances to the value of at least £2 billion per year. As well as insurance responsibilities, many Airmic members are responsible for broader risk management activities, including project, operational and enterprise risk management.

Many members operate at very senior level within their organisations with direct input at Audit Committee and/or Executive Risk Management Committee, as well as making regular Board presentations.
